A. INSTRUCTIONS:-

Please read the following instructions carefully before submitting application form:-

- A. Online Application Form is available on the website of DSLSA *i.e.* www.dlsa.org. The same shall be filled online only.
- B. Hard copy of the application shall not be entertained.
- C. Already empanelled Advocates in DSLSA or DLSAs shall not apply.
- D. Only those candidates who fulfil the eligibility criteria may apply for empanelment.
- E. Please mention your contact number and e-mail address properly.
- F. Candidate must give all required particulars in the application form.
- G. Applications shall be accepted **w.e.f. 12.07.2021 till 24.7.2021.**
- H. No application would be entertained after the last date.

- I. In case, the applicant does not get a confirmation e-mail regarding successful submission of application form within 48 hours, he/she may contact on advocateempanelment@gmail.com .

B. ELIGIBILITY CRITERIA:-

- 1) Applicant must have actual working / practice experience of three years or more at Bar as on **30.03.2021**.
- 2) Applicant must possess sound working knowledge on procedures of District Court, Consumer Forums, DRT, NGT, AFT, CAT, Juvenile Justice Boards (JJB), Child Welfare Committee (CWC) & High Court of Delhi.

C. SELECTION PROCEDURE: -

1. No candidate shall be called for interview unless he/she satisfies the eligibility conditions, during the scrutiny of the Application forms.
2. Merely fulfilling the eligibility criteria will not confer any right on a candidate to be called for interview or selection.
3. Depending upon the applications received and the requirement of DSLSA, the Authority reserves the right to short list the candidates to be called for the Interview.
4. Shortlisted candidates will be informed through e-mail about the date, time and venue of Interview.
5. Candidate shall bring their original LL.B. Degree, Enrolment & Experience Certificate along with self attested copies of their documents at the time of verification.

6. Interview Board will take into consideration that the candidate who shall be appearing in the interview for empanelment as Legal Services Advocate shall be assessed on criteria like personality/ eligibility, legal knowledge/ legal aptitude, commitment/ spirit to work in the field of legal aid, regularity/ availability in the said Tribunals/Commissions.
7. Empanelment result will be displayed on the website of DSLSA i.e. www.dslsa.org.

D. TERMS AND CONDITIONS FOR EMPANELMENT:-

1. New panel shall be for a period of **2 years** commencing from the date of nomination, subject to review of performance/work done by each Legal Services Advocate appointed.
2. Panel Advocates will be paid fees as per approved DSLSA fee schedule, 2017.
3. It will be mandatory for panel Advocates to attend the training programmes and refresher courses organized by Delhi State Legal Services Authority (DSLSA) from time to time including the orientation programme to enable empanelled lawyers to handle legal aid work, as well as training to upgrade skills in various aspects of trial practice, such as the art of cross examination. Absence from such training programmes and courses, without prior permission would be a ground for removal from Panel.
4. Authority reserves the right to avail the services of empanelled advocates to perform duties in Legal Services Clinics, Helpline numbers, Outreach programmes, and Observation Homes etc.

and for any other activities/awareness programmes including presence in the functions to be organised by the Authority.

5. **Removal from Panel:-** If performance of the panel Advocate is found unsatisfactory or the Advocate is found to be guilty of charging or collecting or demanding any remuneration from an aided person in any form or he/she contravenes the Scheme of the Act, Rules and the Regulations, he/she can be removed from the panel and shall also be liable for action for Professional Misconduct as per Regulation 7 of the Delhi State Legal Services Authority Regulations, 2002 as well as provisions of the Advocates Act, 1961 or any other rules or regulation applicable.
6. The Authority reserves its rights to enlarge the scope of the duty of the legal service counsels in order to achieve the aim and objectives of "The Legal Services Authorities Act, 1987".
